#### **Review of last 3 months**

- We have taken up a new contract with foster care provider "Samaritans" in the city of Stara Zagora, Bulgaria. The contract can be found on our page: http://www.kidscarecharity.co.uk/documents
- 2. We increased the salaries in Varna to 680BGN before tax.
- 3. The government funding for the Social Services project has been extended till 30 Oct 2015. It is likely that funding will be granted for further 2y after that TBC. This project supports 30 families in Aksakovo, which "Sauchastie" Varna coordinated.
- 4. Kids Care received an offer for free online training with Fair Start Global, which was passed onto our partners.
- 5. Videos of famous people supporting Kids Care we have 13 videos so far, thanks to YD

#### Meeting with our partners in Bulgaria

- 1. Foster care provider "Sauchastie" Varna
  - a. Current families 29
  - b. Total children supported by Kids Care to date 49, of whom:
    - i. Adopted 11
    - ii. Reintegrated 5
    - iii. Moved to another foster care provider or back to institution 2
    - iv. In foster care currently 31, of which:
      - 1. Registered for adoption 17
      - 2. Working to reintegrate 7
      - Children who will stay in foster care permanently or where the parents have not yet decided if they're willing to take them back - 7
  - c. Training of new foster care applicants 10 new applicants are undergoing training with Government funding [supported by ND]
  - d. Additional funding of 234 BGN was provided for medical care and transport. 100 BGN expensed YTD.

- e. Walker needed for Melanie, who suffers from cerebral palsy.
- f. 10 of the families in Aksakovo have moved to "Sauchastie"
- g. DL offered free online training with Fair Start Global, which the team were keen to try. JA will send details to "Sauchastie".
- h. There is no agreed national financial standard for foster care in Bulgaria. A report was written in 2014, which did not account for the lack of administrative resource at the council to support foster care, as well as other factors (such as travel for the child to meet their biological family, etc).

#### 2. Foster care provider "Samaritans" - Stara Zagora

- a. First meeting with our new partners:
  - i. Desislava Gencheva has worked at "Samaritans" for 8y as a social worker and supports 12 families.
  - ii. Snejana Dimitrova has worked at "Samaritans" for 8y as a psychologist and supports 15 families.
  - iii. Ivaylo Yabalkarov has worked at "Samaritans" for 7y as a coordinator and manager of Foster Care and supports 9 families, which are not funded by Kids Care at present.
- b. "Samaritans" carries out fund-raising activities to supply additional needs for transport, nappies, cosmetics for the children, etc
- c. Current families 27
- d. Current children 29
  - i. Registered for adoption 26, but likely to stay in foster care permanently
  - ii. Working to reintegrate 3 (who were reintegrated unsuccessfully before)
- e. Training of new foster care applicants 4
- f. There are 11 "family-like" homes, where the tendency is for the public social workers not refer them to foster care, so instead of them being temporary placements as they intended to be, they become permanent, thus the children remain institutionalised and the individual care in foster families is hindered.
- g. DL offered distant adoption (sponsors will send fixed monthly payments for a chosen family via "Samaritans" and will receive reports, photos and other materials showing the progress of the family), potentially in 3 areas:
  - i. Supporting prevention of abandonment;
  - ii. Supporting a foster family to take children with special needs or babies;
  - iii. Supporting the biological family to receive their child back from an institution or foster family (reintegration).

## Q3 plans

- 1. Distant adoption
  - a. Biological families to facilitate reintegration
  - b. Prevention from abandonment
  - c. Foster family to meet special medical and learning needs of the child and to afford fostering new born babies (babies go to institutions, because foster families don't have enough support to take them)
